

# Crowley Fuel Co. Easy Pay Contract 2010 – 2011

Name: **Crowley Fuel** Account # **2501** Date: **October 22, 2010**

Due to the volatility of the oil market this contract must be signed and returned with **Automatic Delivery Policy** by October 30, 2010. Previous balance must be paid in full. **This contract is valid from June 1, 2010 through May 31, 2011.**

Conditions:

1. The main purpose for the **Easy Pay Contract** is to allow our customers to spread out their payments over 8 months at an average estimated price per gallon. **There is no additional fee but there is also no protection if prices increase during the term of this contract.** If the price of oil goes down, you will be charged the lower price and build a credit balance. **If the price of oil goes up, you may have to increase the size of your monthly payments.**
2. **Easy Pay Plus:** For an additional 25 cents per gallon you may sign up for our **Easy Pay Plus** contract and guarantee that your price never goes higher than \$3.09
3. Automatic Delivery – This program requires automatic delivery with a tank and oil line that has been inspected and in compliance with state codes. The automatic delivery policy must be read, agreed to, signed, and returned with this contract.
4. A missed payment without prior consent will render this contract null and void.
5. A credit balance on this account in May 2011 may be refunded or rolled over. This contract is binding and will be enforced. Refunds before May 31, 2011 will be made only for reasons that Crowley Fuel Co. deems to be valid. This contract is transferrable to a new homeowner or the original customer moving within our delivery area.
6. **Force Majeure:** Crowley Fuel Co. shall not be responsible for the increase in price caused by delay or failure to perform, in whole or part, hereunder or noncompliance with any of the terms hereof when such delay, failure or noncompliance is attributable to acts of God, strikes, lockouts, fire, floods, storms, legal validity, war conditions, accidents, delays in transportation, any allocation program or rationing or priorities in effect pursuant to governmental direction or request or instituted in cooperation with any governmental authority, or other cause beyond control of Crowley Fuel Co. whether or not similar to those enumerated.
