

Crowley Fuel Co. Easy Pay Plus Contract 2011 - 2012

Due to the volatility of the oil market this contract must be signed and returned with the **Automatic Delivery Policy** signed by *June 15, 2011*. Any previous balance must be paid in full. **This contract is valid from June 1, 2011 through May 31, 2012.**

Conditions:

1. The purpose for the **Easy Pay Plus Contract** is to guarantee you protection against higher prices if prices go up while allowing you to pay lower prices if prices come down, and dividing the total into 12 monthly payments. There is a **non-refundable fee of \$.33 per gallon** which is used to buy the insurance for guaranteeing the price. This fee will be taken out of the first month's payment.
2. **Automatic Delivery** - This program requires automatic delivery, with a tank and oil line that has been inspected and is in compliance with state codes. The **Automatic Delivery Policy** must be read, agreed to, signed, and returned with this contract.
3. A missed payment without prior consent may render this contract **null and void**.
4. Any gallons delivered in addition to the contracted gallons will be billed at the market price on that day.
5. The \$3.99 price per gallon guarantee ends on May 31, 2012, so a credit balance on this account on that date may be refunded or rolled over. Refunds before May 31, 2012 will be made only for reasons that Crowley Fuel Co. deems to be valid. This contract is transferable to a new homeowner at the same address or the original owner moving within our delivery area.
6. **Force Majeure**: Crowley Fuel Co. shall not be responsible for the increase in price caused by delay or failure to perform, in whole or part, hereunder or noncompliance with any of the terms hereof when such delay, failure or noncompliance is attributable to acts of God, strikes, lockouts, fire, floods, storms, legal validity, war conditions, accidents, delays in transportation, any allocation program or rationing or priorities in effect pursuant to governmental direction or request or instituted in cooperation with any governmental authority, or other cause beyond control of Crowley Fuel Co. whether or not similar to those enumerated.
