Due to the volatility of the markets this contract must be signed and returned before June 15, 2011. Previous balance must also be paid in full.

This contract is valid from June 1, 2011 through May 31, 2012.

Conditions:

1. This contract guarantees the above-named customer of Crowley Fuel Co. a price per gallon for heating oil of \$3.99 or less. **There is a non-refundable Cap Fee of \$.33 that must be paid when returning the contract.**
2. *Automatic Delivery* - This program requires automatic delivery with a tank and oil line that has been inspected and in compliance with state codes. The automatic delivery policy must be read, agreed to, signed, and returned with this contract.
3. A missed payment without prior consent may render this contract null and void.
4. Any gallons delivered in addition to the contracted gallons will be billed at the market price on that day.
5. This contract is binding and will be enforced. Refunds will be made only for reasons Crowley Fuel Co. deems to be valid. This contract is transferable to a new homeowner at the same address or to the original customer at a new address within our delivery area.
6. *Force Majeure*: Crowley Fuel Co. shall not be responsible for the increase in price caused by delay or failure to perform, in whole or part, hereunder or noncompliance with any of the terms hereof when such delay, failure or noncompliance is attributable to acts of God, strikes, lockouts, fire, floods, storms, legal validity, war conditions, accidents, delays in transportation, any allocation program or rationing or priorities in effect pursuant to governmental direction or request or instituted in cooperation with any governmental authority, or other cause beyond control of Crowley Fuel Co. whether or not similar to those enumerated.
