We guarantee the following program prices, if signed and returned within 15 days from above date. We will continue to offer these programs beyond this date but reserve the right to re-price them due to market conditions. Any previous balance must be paid in full. This contract is valid from June 1, 2018 through May 31, 2019.

## Conditions:

1. The purpose for the **Prepaid Plus Contract** is to guarantee you protection against higher prices if prices go up while allowing you to pay lower prices if prices come down. There is a **non-refundable fee of \$.22 per gallon** which is used to buy the insurance for guaranteeing the price.
2. *Automatic Delivery* - This program requires automatic delivery to a tank and oil line that has been inspected and in compliance with state codes. The **Automatic Delivery Policy** must be read, agreed to, signed, and returned with this contract.
3. Any gallons delivered in addition to the contracted gallons will be billed at the market price on that day.
4. The \$2.82 price per gallon guarantee ends on May 31, 2019. Unused gallons will be credited as cash and may be refunded, rolled over, or applied to other services. Refunds before May 31, 2019 will be made only for reasons that Tasse/Crowley Fuel Co. deems to be valid. This contract is transferable to a new homeowner at the same address or to the original owner moving within our delivery area.
5. *Force Majeure*: Tasse/Crowley Fuel Co. shall not be responsible for the increase in price caused by delay or failure to perform, in whole or part, hereunder or noncompliance with any of the terms hereof when such delay, failure or noncompliance is attributable to acts of God, strikes, lockouts, fire, floods, storms, legal validity, war conditions, accidents, delays in transportation, any allocation program or rationing or priorities in effect pursuant to governmental direction or request or instituted in cooperation with any governmental authority, or other caused beyond control of Tasse/Crowley Fuel Co. whether or not similar to those enumerated.
